Needs and Challenges:

Assured Independence takes a new approach to providing telehealth services. EES teamed with them to identify, design, and implement a technology plan that would support their growing business. As a start-up company Assured Independence already had numerous contracts and technologies in place, and an even longer list of services that needed to be deployed. Streamlining all aspects of business was critical: VOIP Phones (Voice Over Internet Protocol); a SaaS (Software as a Service) based medical records and billing application; a secure HIPAA complaint faxing service, Secure Printing within the company, and a Virtual Private Network. These were just a few areas needing attention to ensure secure scalable growth for years to come.

EES identified additional areas to improve security and efficiency including network WIFI properly protected with a robust firewall coupled with an Active Directory structure. EES also recommended a support Helpdesk system for monitoring of network and PC support including antivirus malware, monitoring tools, and internet traffic filtering.

- Migrate all computers to Windows 10 Professional
- Secure HIPPA compliant printing & scanning
- Provide and install Office 365 Backup with Spam Filter
- Implement more robust Email Encryption
- Upgrade network hardware including: Firewall, server, access points
- Provide ongoing Cyber Security Training for employees and management

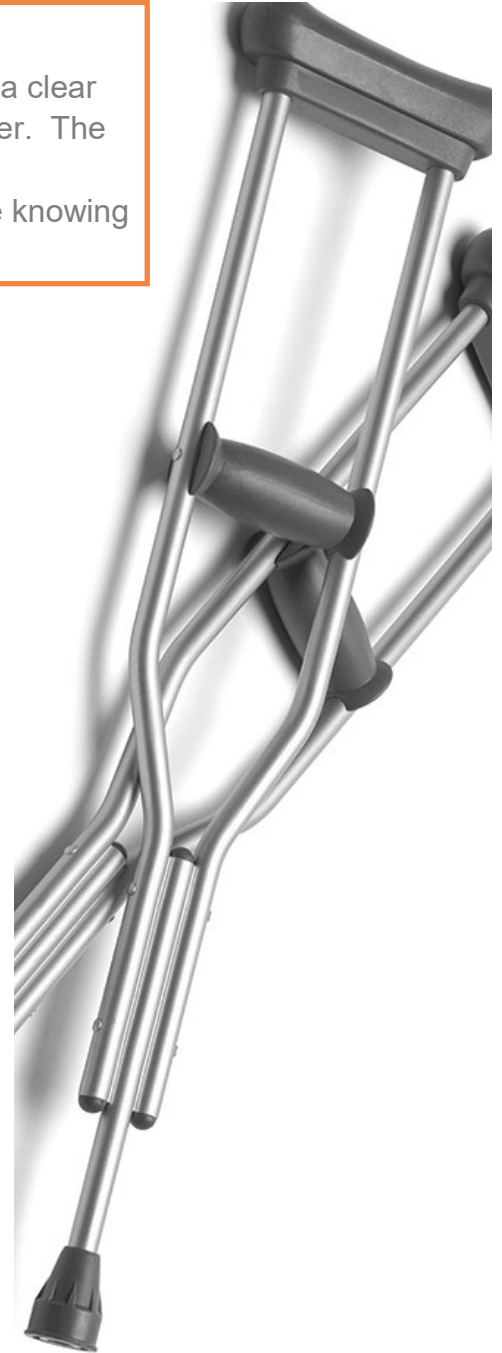
